We are pleased to submit first treated water test results from Taliworks Analytical Laboratory Sdn Bhd for Sullage Water Treatment Plant (SWTP) Tiongnam dated 1.10.2021. These results are for treated sullage water for monitoring of the treatment process to assess its performance.

The National Water Quality Indexes are as follows.

The lab results and comparison for water quality parameters are summarized as follows.

Parameter	Class 2B	Result

DO	5-7	7.7
BOD	3	<0.6

Ammonia Nitrogen	0.3	0.04
Oil and Grease	N.A	<0.2

The above summarized results shown marked the outlet water quality and prove the effectiveness of the treatment implemented to achieve class 2b. The result for DO and Ammonical-nitrogen were much better than the specified one. Overall it has shown further improvement of treatment process by the media when compared with the picture inlet and outlet tank (refer to below pictures). The analysis showed treated water quality has achieved Class 2b. We hope by the passage of time the water quality will further improve much better.
